Summary:

The Mayor's PCC precept proposal, to levy a Band D annual precept of £221.28 which is a £10 increase (4.73%) giving a police precept figure of £147.9m, was unanimously endorsed by the Police and Crime Panel on 4 February 2022.

The Mayor's proposal will result in a total policing budget of £531.611m. Alongside the savings made through the Strategic Delivery and Consultation Group, this will allow non partner-funded PCSO numbers to be maintained at 566 as a key commitment to the Neighbourhood Policing footprint, and ongoing recruitment of an additional 345 police officers and 84 police staff into various specialist roles in helping to meet the overall shared vision of 'Safe, Just, Inclusive'.
