During June 2022, the Violence Reduction Unit (VRU) had Decision Paper MPCC125 agreed by the Executive, which asked the Deputy Mayor to utilise funding from the allocated 22/23 VRU Intervention Budget to complete an Expression of Interest process to commission mentoring support in an identified school within each area - Bradford, Calderdale, Kirklees and Leeds.

Following the expression of interest process for grants up to £80,000 per area, we have been able to identify preferred providers to deliver in Bradford, Calderdale, Kirklees and Leeds. This process identified 2 provides for activity in Bradford and Leeds and identified the same for Calderdale and Kirklees.
