- IDVA services contribution Total allocation 2023-25 £466,000
- Live Links Total allocation 2023-25 £25,000
- To be allocated £143,580

Option B This option is based on West Yorkshire <u>not</u> receiving the MoJ uplift of £235,624 p.a. 2023/24 and 2024/25.

- Jyoti Service Total allocation 2023-25 £90,000
